7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with Oriana House, Inc., as a Best Practical Source, to provide cognitive**
9 **behavioral assessments, referrals, and program services for the Common Pleas Court, for**
10 **the term 10/1/21 through 6/30/23, in an amount not to exceed \$320,000.00, for the**
11 **Executive's Department of Law and Risk Management – Division of Public Safety, and**
12 **declaring an emergency.**

14 WHEREAS, the County of Summit receives funding from the Ohio Department of
15 Rehabilitation and Correction through the Targeted Community Alternatives to Prison and
16 Justice Reinvestment and Incentive programs to provide these services to court-involved
17 individuals in order to maintain them locally; and

19 WHEREAS, Oriana House, Inc. is a Best Practical Source as the agency currently
20 provides these types of services for the Common Pleas Court and they have provided similar
21 community corrections services for the County for years; and

23 WHEREAS, the Board of Control, at its meeting held September 29, 2021, awarded a
24 professional service contract with Oriana House, Inc., as a Best Practical Source, to provide
25 cognitive behavioral assessments, referrals, and program services for the Common Pleas Court,
26 for the term 10/1/21 through 6/30/23, in an amount not to exceed \$320,000.00, subject to
27 confirmation by this Council; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that the aforementioned professional service contract with Oriana House, Inc. is necessary and in
31 the best interest of the County of Summit;

33 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

38 The award by the Board of Control of a professional service contract with Oriana House,
39 Inc., as a Best Practical Source, to provide cognitive behavioral assessments, referrals and
40 program services for the Common Pleas Court, for the term 10/1/21 through 6/30/23, in an
41 amount not to exceed \$320,000.00 is hereby confirmed and the Executive is hereby authorized to
42 execute said professional service contract and any necessary related documents.

46 This Resolution is hereby declared an emergency in the interest of health, safety and
47 welfare of the residents of the County of Summit, and for the further reason to immediately
48 continue expend program funds within the grant period.
