7 **A Resolution authorizing the Executive to execute any documents necessary to accept an**
8 **award from the Ohio Department of Public Safety's Office of Criminal Justice Services of a**
9 **Drug Unit Recovery Grant, for the period 1/1/21 through 3/31/22, in the amount of**
10 **\$116,701.06, with no local cash match requirement, for the Sheriff, and declaring an**
11 **emergency.**

13 WHEREAS, the Ohio Department of Public Safety's Office of Criminal Justice Services
14 ("ODPS-OCJS") has awarded the Sheriff's Office a Drug Unit Recovery Grant, for the period
15 1/1/21 through 3/31/22, in the amount of \$116,701.06, with no local cash match requirement; and

17 WHEREAS, this grant will pay for vehicles and vehicle maintenance, Global Positioning
18 System subscription fees and Drug Unit staff overtime to allow the Sheriff's Department to
19 continue to target the manufacture, distribution and acquisition of illegal drugs in Summit County;

22 WHEREAS, the ODPS-OCJS requires this Council's approval for acceptance of the Drug
23 Unit Recovery Grant; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
27 execute any documents necessary to accept the award of the aforementioned grant from the ODPS-
28 OCJS;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The Executive is hereby authorized to execute any documents necessary to accept the
36 award by the Ohio Department of Public Safety's Office of Criminal Justice Services ("ODPS-
37 OCJS") of a Drug Unit Recovery grant, for the period 1/1/21 through 3/31/22, in the amount of
38 \$116,701.06, with no local cash match requirement.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the residents of the County of Summit and for the further reason to immediately
44 authorize the Executive to execute any documents necessary to accept the award of the Drug Unit
45 Recovery Grant from ODPS-OCJS, so that the same may be used to fund the Sheriff's Drug Unit
46 within the grant performance period.

16 of the Ohio Revised Code.


