7 **A Resolution authorizing the Executive to advertise for bids for the Children Services**  
8 **Boiler Replacement Project, for Children Services Administration Building, located in**  
9 **Akron, in District 4, for an estimated total cost not to exceed \$197,000.00, for the**  
10 **Executive's Department of Administrative Services-Physical Plants, and declaring an**  
11 **emergency.**

13 WHEREAS, the Administration Building for Summit County Children Services, located  
14 at 264 S Arlington St, Akron, Ohio, in Council District 4, was built in 1996; and

15  
16 WHEREAS, the existing boilers, which were installed when the building was built, are  
17 reaching the end of their service life and replacement parts are difficult to obtain; and

18  
19 WHEREAS, the Executive wishes to undertake the Children Services Boiler  
20 Replacement Project, to replace the existing boilers in the building with new boilers that will be  
21 more reliable and energy efficient; and

22  
23 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
24 requires this Council's authorization for the Executive to advertise for bids; and

25  
26 WHEREAS, the Executive wishes to advertise for bids for the aforementioned Project,  
27 for an estimated total cost not to exceed \$197,000.00; and

29 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's Office;

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
34 advertise for bids for the Project, for an estimated total cost not to exceed \$197,000.00;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
37 of Ohio, that:

41 The Executive is hereby authorized to advertise for bids for the Children Services Boiler  
42 Replacement Project, for Children Services Administration Building, located in Akron, in  
43 District 4, for an estimated total cost not to exceed \$197,000.00.

47 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
48 of the residents of the County of Summit, and for the further reason that it authorizes the  
49 Executive to immediately advertisement for bids for necessary replacement of boilers at the  
50 Children Services Administration Building.
