8 **AdvizeX Technologies LLC, at State Term Pricing, for hardware necessary to complete**
9 **updates and host replacements, in an amount not to exceed \$74,460.00, for the Office of**
10 **Information Technology, and declaring an emergency.**

12 WHEREAS, the Executive wishes to enter into a purchase contract with AdvizeX
13 Technologies LLC for the hardware necessary to complete updates and replace host servers for
14 the Office of Information Technology; and

16 WHEREAS, the Board of Control, at its meeting held on November 3, 2021, awarded
17 subject to the approval of the Information Technology Board, a purchase contract with AdvizeX
18 Technologies LLC, at State Term Pricing, for hardware necessary to complete updates and host
19 replacements, in an amount not to exceed \$74,460.00, subject to confirmation by this Council;

22 WHEREAS, the Information Technology Board, at its meeting held on November 4,
23 2021, approved the aforementioned purchase contract with AdvizeX Technologies LLC, at State
24 Term Pricing, to provide said hardware; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that the aforementioned purchase contract with AdvizeX Technologies LLC is necessary and in
28 the best interest of the County of Summit;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

35 The award by the Board of Control of a purchase contract, approved by the Information
36 Technology Board on 11/4/21, with AdvizeX Technologies LLC, at State Term Pricing, for
37 hardware necessary to complete updates and host replacements in an amount not to exceed
38 \$74,460.00, is hereby confirmed and the Executive is hereby authorized to execute said purchase
39 contract and any other necessary related documents.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit, and for the further reason of immediately
45 providing necessary hardware to complete updates and host replacements.

50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
