7 **A Resolution confirming the award by the Board of Control, of a purchase contract with**  
8 **Shaw Industries, Inc., at State Term pricing, for the replacement of carpet and vinyl**  
9 **flooring at the Jail, located in Akron, in Council District 4, in an amount not to exceed**  
10 **\$51,889.12, for the Executive's Department of Administrative Services-Physical Plants,**  
11 **and declaring an emergency.**

13 WHEREAS, the original carpet and vinyl flooring at the Jail, located at 205 E Crosier St,  
14 Akron, Ohio 44311, in Council District 4, is in poor condition, past its service life and must be  
15 replaced in several areas; and

16  
17 WHEREAS, this project will replace the flooring in 21 rooms in the administration area  
18 of the Jail; and

20 WHEREAS, the Executive wishes to enter into a purchase contract with Shaw Industries,  
21 Inc., at State Term pricing, for this project, in an amount not to exceed \$51,889.12; and

23 WHEREAS, the Board of Control, at its meeting held November 3, 2021, awarded a  
24 purchase contract with Shaw Industries, Inc., at State Term pricing, for this project, in an amount  
25 not to exceed \$51,889.12; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
28 that the aforementioned purchase contract with Shaw Industries, Inc. is necessary and in the best  
29 interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that:

34 SECTION 1

36 The award by the Board of Control of a purchase contract with Shaw Industries, Inc., at  
37 State Term pricing, for the replacement of carpet and vinyl flooring at the Jail, located in Akron,  
38 in Council District 4, in an amount not to exceed \$51,889.12, is hereby confirmed and the  
39 Executive is hereby authorized to execute said purchase contract and any other necessary related  
40 documents.

44 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
45 of the residents of the County of Summit, and for the further reason that it authorizes the  
46 Executive to immediately begin the replacement of carpet and vinyl flooring at the Jail.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take  
51 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
52 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


