7 **A Resolution authorizing the Executive to advertise for bids for the Brandywine Road**  
8 **Bridge over Brandywine Creek Rehabilitation Project, located in Northfield Center**  
9 **Township, Council District 1, for an estimated total cost not to exceed \$975,000.00, for the**  
10 **Engineer and declaring an emergency.**

11  
12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
13 requires this Council's authorization for the Executive to advertise for bids; and

14  
15 WHEREAS, the Brandywine Road Bridge over Brandywine Creek, structure number  
16 NOR-040-0157, is in poor condition and requires rehabilitation; and

17  
18 WHEREAS, the Engineer estimates the cost of the bridge rehabilitation to be  
19 \$975,000.00; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
23 advertise for bids for the Brandywine Road Bridge over Brandywine Creek Rehabilitation  
24 Project.

26 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
27 of Ohio, that:

29 SECTION 1

31 The Executive is hereby authorized to advertise for bids for the Brandywine Road Bridge  
32 over Brandywine Creek Rehabilitation Project, located in Northfield Center Township, Council  
33 District 1, at a cost not to exceed \$975,000.00.

35 SECTION 2

37 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
38 welfare of the residents of the County of Summit, and for the further reason that it will allow the  
39 County to repair a bridge in poor condition in a timely fashion.

41 SECTION 3

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


