7 **A Resolution authorizing the Executive, subject to the approval of the Board of Control, to**
8 **execute a purchase contract with Safeware, Inc. for twenty-five hazardous materials**
9 **protective suits for Stark County's Hazardous Materials Response Team, in an amount not**
10 **to exceed \$54,176.50, for the Executive's Department of Law and Risk Management-**
11 **Division of Public Safety, Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2021-239, which authorized
14 the Executive to advertise for bids for twenty-five hazardous materials protective suits for Stark
15 County's Hazardous Materials Response Team for an estimated total cost not to exceed
16 \$65,000.00; and

18 WHEREAS, after advertising for bids and receiving bids from six vendors, the Executive
19 accepted the lowest responsive and responsible bid from Safeware, Inc. in the amount of
20 \$54,176.50; and

22 WHEREAS, the Executive will recommend to the Board of Control, at its meeting to be
23 held on October 27, 2021, that the Board award a purchase contract with Safeware, Inc. for
24 twenty-five hazardous materials protective suits for Stark County's Hazardous Materials
25 Response Team, in an amount not to exceed \$54,176.50; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the Executive,
29 subject to the approval of the Board of Control, to execute the aforementioned purchase contract
30 with Safeware, Inc.;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The Executive is hereby authorized, subject to the approval of the Board of Control, to
38 execute a purchase contract with Safeware, Inc. for twenty-five hazardous materials protective
39 suits for Stark County's Hazardous Materials Response Team, in an amount not to exceed
40 \$54,176.50, and any other necessary related documents.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the residents of the County of Summit, and for the further reason to immediately
46 provide for necessary hazardous materials protective suits for Stark County's Hazardous
47 Materials Response Team, and expending grant funds in a timely manner.

51 Provided this Resolution receives the affirmative vote of eight members, it shall take
52 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
