7 **A Resolution confirming the award by the Board of Control of a purchase contract with All**
8 **Safe Industries, Inc. for four search and rescue camera kits, for Summit County's Special**
9 **Operations Search and Rescue Team for an estimated total cost not to exceed \$52,350.68,**
10 **for the Executive's Department of Law and Risk Management-Division of Public Safety,**
11 **Emergency Management Agency, and declaring an emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2021-239, which authorized
14 the Executive to advertise for bids for four search and rescue camera kits, for Summit County's
15 Special Operations Search and Rescue Team for an estimated total cost not to exceed
16 \$65,000.00; and

17
18 WHEREAS, after advertising for bids and sending out bid packages to twenty-one
19 potential bidders, the Executive accepted the lowest responsive and responsible bid from All
20 Safe Industries, Inc. in the amount of \$52,350.68; and

22 WHEREAS, the Board of Control, at its meeting held October 20, 2021, awarded a
23 purchase contract with All Safe Industries, Inc. for four search and rescue camera kits, for
24 Summit County's Special Operations Search and Rescue Team for an estimated total cost not to
25 exceed \$52,350.68, subject to confirmation by this Council; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that the aforementioned purchase contract with All Safe Industries, Inc. is necessary and in the
29 best interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
32 of Ohio, that:

36 The award by the Board of Control of a purchase contract with All Safe Industries, Inc.
37 for four search and rescue camera kits, for Summit County's Special Operations Search and
38 Rescue Team for an estimated total cost not to exceed \$52,350.68, is hereby confirmed and the
39 Executive is hereby authorized to execute said purchase contract and any other necessary related
40 documents.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the residents of the County of Summit, and for the further reason to immediately
46 provide for necessary search and rescue camera kits for Summit County's Special Operations
47 Search and Rescue Team and expending grant funds in a timely manner.

51 Provided this Resolution receives the affirmative vote of eight members, it shall take
52 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take


