33 set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the residents of the County of Summit and for the further reason that the
39 appropriations contained in Exhibit A are immediately needed for operations of the Alcohol
40 Drug and Mental Health Services Board of the County of Summit.

44 Provided this Resolution receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.




