7 **A Resolution authorizing the Executive to execute any documents necessary to accept the**
8 **award from the State of Ohio Attorney General's Office of a Federal Fiscal Year 2022**
9 **Victims of Crime Act grant, in the amount of \$205,637.00, with a 20% local cash match**
10 **requirement of \$51,409.25, the period 10/1/21 through 9/30/22, for the Prosecutor, and**
11 **declaring an emergency.**

13 WHEREAS, the Prosecutor has received an award from the State of Ohio Attorney
14 General's Office of a Federal Fiscal Year 2022 Victims of Crime Act ("VOCA") grant for the
15 period 10/1/21 through 9/30/22, for a VOCA award total of \$257,046.25; and

17 WHEREAS, the VOCA is an annual grant which helps to support salary and benefits for
18 five full-time Victim Advocates; and

20 WHEREAS, the Prosecutor provides for the required VOCA grant match within her
21 annual budget; and

23 WHEREAS, Section 130.04 of the Codified Ordinances of the County of Summit
24 requires this Council's authorization for the execution of grant agreements when the County's
25 local cash match requirement exceeds \$25,000.00; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
29 execute any documents necessary to accept the award of the aforementioned VOCA grant from
30 the State of Ohio Attorney General's Office;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The Executive is hereby authorized to execute any documents necessary to accept the
38 award from the State of Ohio Attorney General's Office of a Federal Fiscal Year 2022 Victims
39 of Crime Act ("VOCA") grant for the period 10/1/21 through 9/30/22, in the amount of
40 \$205,637.00, with a 20% local cash match requirement of \$51,409.25.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the residents of the County of Summit and for the further reason to immediately
46 authorize the Executive to execute any documents necessary to accept the award of the Federal
47 Fiscal Year 2022 VOCA grant.

51 Provided this Resolution receives the affirmative vote of eight members, it shall take
52 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take

14 121.22 of the Ohio Revised Code.


