7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Zenn Outfitters, LLC for a mobile surveillance tower for Ohio Homeland Security Region 5**
9 **Law Enforcement for an estimated total cost not to exceed \$149,104.85, for the Executive's**
10 **Department of Public Safety, Emergency Management Agency and declaring an emergency.**

12 WHEREAS, the Executive's Department of Public Safety, Emergency Management
13 Agency wishes to purchase a mobile surveillance tower to be utilized at large gatherings
14 throughout the 13 counties within Ohio Homeland Security Region 5 to provide additional
15 situational awareness for law enforcement personnel; and

17 WHEREAS, this Council previously adopted Resolution No. 2021-319, which authorized
18 the Executive to advertise for bids for said mobile surveillance tower, for an estimated amount not
19 to exceed \$165,000.00; and

21 WHEREAS, after advertising for bids, the Executive has selected Zenn Outfitter, LLC as
22 the lowest responsive and responsible bidder; and

24 WHEREAS, the Board of Control, at its meeting held January 5, 2022, awarded a purchase
25 contract with Zenn Outfitters, LLC for the mobile surveillance tower, in an amount not to exceed
26 \$149,104.85; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that said purchase contract with Zenn Outfitters, LLC is necessary and in the best interest of the
30 County of Summit;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The award by Board of Control of a purchase contract with Zenn Outfitters, LLC for a
38 mobile surveillance tower for Ohio Homeland Security Region 5 Law Enforcement for an
39 estimated total cost not to exceed \$149,104.85 is hereby confirmed and the Executive is hereby
40 authorized to execute said purchase contract and any other necessary related documents.

45 of the residents of the County of Summit, and for the further reason that it immediately provides
46 for necessary Emergency Management Agency equipment.
