8 **A Resolution adopting the Capital Improvements Program for 2022-2027 for the County of**
9 **Summit and appropriating funds as set forth in Exhibit A, for the balance of projects in the**
10 **2022 Capital Improvement Plan, for the Executive's Department of Finance and Budget,**
11 **and declaring an emergency.**

13 WHEREAS, Section 2.03 of the Codified Ordinances of the County of Summit requires
14 the Executive to submit a Capital Improvements Program to this Council by February 15 of each
15 year; and

17 WHEREAS, appropriations are now required for the balance of projects in the 2022
18 Capital Improvements Program as set forth in Exhibit A, attached to this Resolution and
19 incorporated herein as if fully restated; and

21 WHEREAS, this Council has determined by reviewing all pertinent information that
22 adopting the Capital Improvements Program and appropriating funds in the 2022 Capital
23 Improvement Program is necessary and in the best interest of the County of Summit;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

30 The Capital Improvement Program for the period 2022-2027, attached hereto and
31 incorporated herein as if fully restated, is hereby approved and adopted for the County of
32 Summit and the Fiscal Officer is hereby authorized and directed to effect the appropriations set
33 forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the residents of the County of Summit and for the further reason that the
39 appropriations contained in Exhibit A are immediately needed for operations of the County.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
