7 **A Resolution declaring the month of March 2022 as Developmental Disabilities Awareness**
8 **Month in Summit County, and recognizing persons with developmental disabilities, as well**
9 **as the struggles and roadblocks they have faced and continue to face, for the Executive, and**
10 **declaring an emergency.**

12 WHEREAS, the National Association of Councils on Developmental Disabilities
13 celebrates March as Developmental Disabilities Awareness Month with an annual campaign to
14 raise awareness and increase the inclusion of people with developmental disabilities in all areas of
15 life, with the intention to highlight the barriers that inhibit people with disabilities from connecting
16 to the communities in which they live; and

17
18 WHEREAS, it is important to recognize that the inclusion of people with developmental
19 disabilities creates strong, diverse communities where all residents feel welcomed and valued; and

21 WHEREAS, the Ohio Developmental Disabilities Council and the Summit County
22 Developmental Disabilities Board participate in Developmental Disabilities Awareness Month by
23 hosting events and initiatives; and

25 WHEREAS, these initiatives include Inclusion Day on March 7, 2022, on which the
26 Summit County Developmental Disabilities Board celebrates by turning Summit County orange
27 through clothes, stickers, signs, and social media posts, as well as Inclusion Day at the Zoo, where
28 the Summit County Developmental Disabilities Board partners with the Akron Zoo to offer free
29 admission to guests wearing orange; and

31 WHEREAS, it is beneficial to promote these events so that all residents of Summit County
32 are encouraged to participate; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit that March 2022 be declared
36 Developmental Disabilities Month in Summit County, and encouraging the residents of Summit
37 County to join in this acknowledgement;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:

44 The month of March 2022 is hereby declared Developmental Disabilities Awareness
45 Month in Summit County, and the residents of Summit County are encouraged to join in this
