7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **the Community Health Center, as a Best Practical Source, for drug screen testing services,**
9 **in an amount not to exceed \$80,000.00, in calendar year 2022, for the Court of Common**
10 **Pleas-General Division, Adult Probation Department, and declaring an emergency.**

12 WHEREAS, the Court of Common Pleas-General Division, Adult Probation Department
13 (the "Court") has used Community Health Center ("CHC") to drug test adult probationers for a
14 number of years; and

15
16 WHEREAS, in addition to their lengthy relationship with the Court, CHC is a Best
17 Practical Source pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified
18 Ordinances of the County of Summit because CHC provides the most extensive and observed
19 drug testing in Summit County; and

21 WHEREAS, the Court spent \$80,000.00 on drug testing in 2021 and anticipates the costs
22 to be comparable in 2022; and

24 WHEREAS, the Board of Control, at its meeting held on February 9, 2022, awarded a
25 purchase contract with the CHC, as a Best Practical Source, for drug screen testing services, in
26 an amount not to exceed \$80,000.00, in calendar year 2022; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that the aforementioned purchase contract with CHC is necessary and in the best interest of the
30 County of Summit;

32 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The award by the Board of Control of a purchase contract with the Community Health
38 Center, as a Best Practical Source, for drug screen testing services, in an amount not to exceed
39 \$80,000.00, in calendar year 2022, is hereby confirmed and the Executive is hereby authorized to
40 execute said purchase contract and any other necessary related documents.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and
45 welfare of the residents of the County of Summit, and for the further reason to immediately
46 provide necessary drug screen testing services for the Court of Common Pleas-General Division,
47 Adult Probation Department in calendar year 2022.

16 121.22 of the Ohio Revised Code.


