7 **A Resolution authorizing the Executive to execute agreements for the acquisition of**
8 **standard highway easements at 1516 North Revere Road and 1530 North Revere Road,**
9 **located in Bath Township, Council District 4, in a total amount not to exceed \$3,510.00, as**
10 **part of the Revere Road Bridge Replacement Project, for the Engineer, and declaring an**
11 **emergency.**

13 WHEREAS, there is a public need to replace the Revere Road Bridge (BAT-114-0320)
14 located in Bath Township, Council District 4 (the "Project"); and

15
16 WHEREAS, certain land must be acquired by the County of Summit to be utilized as a
17 standard highway easement as part of the Project; and

18
19 WHEREAS, acquisition of lands for easements for the Project is considered a local cost,
20 which must be borne in whole by the local public agency performing the Project; and

22 WHEREAS, the County of Summit has negotiated terms for agreements for the
23 acquisition of standard highway easements at 1516 North Revere Road and 1530 North Revere
24 Road in Bath Township, Council District 4; and

26 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
27 is necessary and in the best interest of the County of Summit to authorize the Executive to
28 execute the aforementioned agreements for the acquisition of standard highway easements;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that;

35 The Executive is hereby authorized to execute agreements for the acquisition of standard
36 highway easements at 1516 North Revere Road and 1530 North Revere Road, in Bath Township,
37 Council District 4, in a total amount not to exceed \$3,510.00, as part of the Revere Road Bridge
38 Replacement Project, with the owners of said properties, and in the amounts as follows:

14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.

23 121.05 of the Ohio Revised Code.


