7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **J.D. Williamson Construction Co., Inc. for the Brandywine Road Bridge over Brandywine**
9 **Creek Rehabilitation Project, located in Northfield Center Township, in Council District 1,**
10 **for an amount not to exceed \$1,028,845.41, for the Engineer and declaring an emergency.**

12 WHEREAS, the Brandywine Road Bridge over Brandywine Creek, structure number
13 NOR-040-0157, located in Northfield Center Township, in Council District 1, is in poor
14 condition and requires rehabilitation; and

15
16 WHEREAS, the Brandywine Road Bridge over Brandywine Creek Rehabilitation Project
17 (the "Project"), will include a new reinforced concrete deck, new bridge railing, new beam
18 bearings, structural steel repairs, field painting of structural steel substructure repairs, new
19 reinforced concrete approach slabs, and minimal approach roadway work, which will result in a
20 traffic detour; and

21
22 WHEREAS, this Council previously adopted Resolution No. 2021-377, which authorized
23 the Executive to advertise for bids for the Project for an estimated total cost not to exceed
24 \$975,000.00; and

26 WHEREAS, after advertising for bids, the Engineer received bids from two firms and the
27 Executive selected J.D. Williamson Construction Co., Inc., as the lowest responsive and
28 responsible bidder; and

30 WHEREAS, the Board of Control, at its meeting held March 2, 2022, awarded a
31 construction contract with J.D. Williamson Construction Co., Inc., for the Project, for an amount
32 not to exceed \$1,028,845.41, subject to confirmation by this Council; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that the aforementioned construction contract with J.D. Williamson Construction Co., Inc. is
36 necessary and in the best interest of the County of Summit;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

43 The award by the Board of Control of a construction contract with J.D. Williamson
44 Construction Co., Inc. for the Brandywine Road Bridge over Brandywine Creek Rehabilitation
45 Project, located in Northfield Center Township, in Council District 1, for an amount not to
46 exceed \$1,028,845.41 is hereby confirmed and the Executive is hereby authorized to execute said
47 construction contract and any other necessary related documents.

8 County to repair a bridge in poor condition in a timely fashion.

13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
14 effect and be in force at the earliest time provided by law.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,

22 121.22 of the Ohio Revised Code.


