A Resolution confirming the award by the Board of Control of a construction contract with J.D. Williamson Construction Co., Inc. for the Brandywine Road Bridge over Brandywine Creek Rehabilitation Project, located in Northfield Center Township, in Council District 1, for an amount not to exceed \$1,028,845.41, for the Engineer and declaring an emergency.

WHEREAS, the Brandywine Road Bridge over Brandywine Creek, structure number NOR-040-0157, located in Northfield Center Township, in Council District 1, is in poor condition and requires rehabilitation; and

WHEREAS, the Brandywine Road Bridge over Brandywine Creek Rehabilitation Project (the "Project"), will include a new reinforced concrete deck, new bridge railing, new beam bearings, structural steel repairs, field painting of structural steel substructure repairs, new reinforced concrete approach slabs, and minimal approach roadway work, which will result in a traffic detour; and

WHEREAS, this Council previously adopted Resolution No. 2021-377, which authorized the Executive to advertise for bids for the Project for an estimated total cost not to exceed \$975,000.00; and

WHEREAS, after advertising for bids, the Engineer received bids from two firms and the Executive selected J.D. Williamson Construction Co., Inc., as the lowest responsive and responsible bidder; and

WHEREAS, the Board of Control, at its meeting held March 2, 2022, awarded a construction contract with J.D. Williamson Construction Co., Inc., for the Project, for an amount not to exceed \$1,028,845.41, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned construction contract with J.D. Williamson Construction Co., Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a construction contract with J.D. Williamson Construction Co., Inc. for the Brandywine Road Bridge over Brandywine Creek Rehabilitation Project, located in Northfield Center Township, in Council District 1, for an amount not to exceed \$1,028,845.41 is hereby confirmed and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.
