7 **A Resolution confirming the award by the Board of Control of a professional service**  
8 **contract with Tri-County Jobs for Ohio's Graduates for 2022 Summer Youth Employment**  
9 **Program outreach and eligibility services, for the period of 4/1/22 through 8/31/22, in an**  
10 **amount not to exceed \$85,000.00, for the Executive's Department of Job and Family**  
11 **Services, and declaring an emergency.**

13 WHEREAS, the Executive wishes to enter an agreement with Tri-County Jobs for Ohio's  
14 Graduates ("JOG") for 2022 Summer Youth Employment Program outreach and eligibility  
15 services; and

16  
17 WHEREAS, under the agreement, JOG will be responsible for employer recruitment,  
18 youth job matching, keeping job slots filled, site monitoring, picking up time sheets to be sent to  
19 a payroll vendor, general supervision and troubleshooting day-to-day issues; and

20  
21 WHEREAS, JOG will also be responsible for adhering to reporting requirements,  
22 providing oversight of supervisory staff, work readiness skills training and general guidance to  
23 youth who are assigned to various work experience sites throughout Summit County; and

25 WHEREAS, the Board of Control, at its meeting held March 9, 2022, awarded a  
26 professional service contract with Tri-County Jobs for Ohio's Graduates for 2022 Summer Youth  
27 Employment Program outreach and eligibility services, for the period of 4/1/22 through 8/31/22,  
28 in an amount not to exceed \$85,000.00, subject to confirmation by this Council; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that a professional service contract with Tri-County Jobs is necessary and in the best interest of  
32 the County of Summit;

34 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that:

39 The award of a professional service contract with Tri-County Jobs for Ohio's Graduates  
40 for 2022 Summer Youth Employment Program outreach and eligibility services, which is exempt  
41 from competitive bidding due to the provider's subgrantee status, for the period of 4/1/22  
42 through 8/31/22, in an amount not to exceed \$85,000.00, is hereby confirmed and the Executive  
43 is hereby authorized to execute said professional service contract and any necessary related  
44 documents.

48 This Resolution is hereby declared an emergency in the interest of the health, safety and  
49 welfare of the residents of Summit County, and for the further reason to immediately approve the  
50 necessary professional service contract to provide outreach and eligibility determination services.
