7 **A Resolution authorizing the Executive to execute a subgrant agreement with the Summit**
8 **and Medina Workforce Area Council of Governments, in a total amount not to exceed**
9 **\$148,193.11, for a period of 1/1/22, through 6/30/23, as set forth in Exhibit A, for the**
10 **Executive’s Department of Community and Economic Development, and declaring an**
11 **emergency.**

13 WHEREAS, the County of Summit and Greater Akron Chamber, along with various
14 other partners, began implementation of the Elevate Greater Akron Economic Plan (“EGA”) in
15 2018 which allowed for better alignment of County and Chamber Economic Development Staff
16 conducting business retention and expansion activity; and

17
18 WHEREAS, under the EGA plan the County of Summit is responsible for reaching out to
19 and maintaining relationships various local businesses alongside the Greater Akron Chamber;
20 and

22 WHEREAS, the County of Summit partnered with the Summit and Medina Workforce
23 Area Council of Governments (“COG”) to apply for Business Resource Network (“BRN”) grant
24 funds from the Ohio Department of Job and Family Services (“ODJFS”) on 12/6/21; and

26 WHEREAS, the COG received an award notice from ODJFS on 1/18/22 regarding the
27 BRN grant program; and

29 WHEREAS, the Executive wishes to enter into a subgrant agreement with the COG to
30 fund business retention and expansion activity primarily aimed at assisting, and enhancing
31 delivery of workforce development services provided by the County of Summit, the COG and its
32 service providers; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
36 execute grant agreements with the Summit County nonprofit organizations and State mandated
37 entities set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully
38 restated;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

45 The Executive is hereby authorized to execute a subgrant agreement and any necessary
46 related documents with the Summit and Medina Workforce Area Council of Governments, in a
47 total amount not to exceed \$148,193.11, for a period of 1/1/22 through 6/30/23, as set forth in
48 Exhibit A, a copy of which is attached hereto and incorporated fully herein, with such
49 modifications and revisions as shall be in furtherance of the provisions of said subgrant
50 agreement and not substantially adverse to the County, all of which shall be conclusively
51 evidenced by the execution thereof by the Executive.

8 wishes to immediately provide support through grants to various Summit County nonprofit
9 organizations and State mandated entities.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.

20 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
21 deliberations of this Council and of any of its committees that resulted in such formal action,

23 121.22 of the Ohio Revised Code.


