10 WHEREAS, the Prosecutor wishes to grant a salary adjustment for classified non-
11 bargaining employee Melanie Hart; and

13 WHEREAS, because a salary adjustment for the aforementioned employee represents a
14 pay increase under Section 169.07 of the Codified Ordinances of the County of Summit, this
15 Council's approval is required; and

17 WHEREAS, the Director of the Department of Human Resources will review the
18 personnel action for the aforementioned salary adjustment as required by Section 169.07(b) of
19 the Codified Ordinances; and

21 WHEREAS, the salary adjustment will be submitted to the Director of the Department of
22 Finance and Budget for the certification of availability of appropriated funds, as required by
23 Section 169.07(b) of the Codified Ordinances; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned salary adjustment is necessary and in the best interest of the County of
27 Summit;


