7 **A Resolution confirming the award by the Board of Control of a professional service**
8 **contract with One of a Kind Pets for veterinarian services at the Animal Control Facility,**
9 **located in the City of Akron, in Council District 5, in a total amount not to exceed**
10 **\$80,000.00, for the Executive's Department of Administrative Services – Division of Animal**
11 **Control, and declaring an emergency.**

13 WHEREAS, the Executive's Department of Administrative Services – Division of
14 Animal Control wishes to enter into a professional service contract with One of a Kind Pets for
15 veterinarian services at the Animal Control Facility; and

16
17 WHEREAS, said services are required for operating the facility including spay and
18 neutering surgeries, and the Animal Control Facility's current veterinarian is leaving for another
19 employment opportunity and must be replaced by June 3, 2022; and

21 WHEREAS, the aforementioned contract with One of a Kind Pets, as a professional
22 service contract, is exempt from competitive bidding pursuant to sections 177.07(4) and 177.08
23 of the Codified Ordinances of the County of Summit; and

25 WHEREAS, the Board of Control, at its meeting held May 18, 2022, awarded a
26 professional service contract with One of a Kind Pets for veterinarian services at the Animal
27 Control Facility, located in the City of Akron, in Council District 5, in a total amount not to
28 exceed \$80,000.00, subject to confirmation by this Council; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that the aforementioned contract with One of a Kind Pets is necessary and in the best interest of
32 the County of Summit;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The award by the Board of Control of a professional service contract with One of a Kind
40 Pets for veterinarian services at the Animal Control Facility, located in the City of Akron, in
41 Council District 5, in a total amount not to exceed \$80,000.00, is hereby confirmed and the
42 Executive is hereby authorized to execute said contract and any necessary related documents.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the residents of the County of Summit, and for the further purpose of immediately
48 providing continued veterinarian services at the Animal Control Facility.

16 121.22 of the Ohio Revised Code.


