7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **National Industrial Maintenance, Inc. for the 2022 Summit County Regional Crack Sealing**
9 **Program, in an amount not to exceed \$262,102.71, for the Engineer, and declaring an**
10 **emergency.**

11
12 WHEREAS, this Council previously adopted Resolution No. 2021-388, which authorized
13 the Executive to advertise, as needed, for bridge engineering and construction projects, and
14 pavement maintenance projects, for the Engineer’s 2022 Capital Improvements Program, and
15 federal and state funded projects, for an estimated total cost not to exceed \$12,724,400.00; and

16
17 WHEREAS, said projects were approved as part of the Capital Improvements Program
18 for 2022-2027 by Resolution No. 2022-032; and

19
20 WHEREAS, following the receipt and review of bids, the Executive proposes entering
21 into a construction contract with National Industrial Maintenance, Inc. for the 2022 Summit
22 County Regional Crack Sealing Program, in an amount not to exceed \$262,102.71; and

24 WHEREAS, the proposed work to be performed consists of preparing and sealing
25 pavement cracks with hot applied crack sealant per ODOT specification item No. 423 Crack
26 Sealing, Hot Applied, Type IV; and

28 WHEREAS, the contract total will be broken down by participating political subdivisions
29 as follows with each subdivision responsible for directly paying the contractor:

- 30 County share: \$107,911.58
- 31 New Franklin: \$83,747.93
- 32 Twinsburg Twp: \$70,443.20; and

35 WHEREAS, the Board of Control, at its meeting held May 18, 2022, awarded a
36 construction contract with National Industrial Maintenance, Inc., as the lowest responsive and
37 responsible bidder, for the 2022 Summit County Regional Crack Sealing Program, in an amount
38 not to exceed \$262,102.71, subject to confirmation by this Council; and

40 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
41 that aforementioned construction contract with National Industrial Maintenance, Inc. is necessary
42 and in the best interest of the County of Summit;

44 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
45 of Ohio, that;

7 execute said construction contract and any other necessary related documents.

11 This Resolution is hereby declared an emergency in the interest of the health, safety and
12 welfare of the residents of the County of Summit, and for the further purpose to immediately
13 provide a necessary construction contract for the 2022 Summit County Regional Crack Sealing
14 Program.

18 Provided this Resolution receives the affirmative vote of eight members, it shall take
19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
20 effect and be in force at the earliest time provided by law.

25 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
26 deliberations of this Council and of any of its committees that resulted in such formal action,
