WHEREAS, the carpet located in the basement and on the first floor of the Domestic Relations Annex to the Courthouse, servicing the Clerk of Courts, has reached the end of its useful life, having been installed in 2004; and

WHEREAS, said project was previously approved by this Council, for an estimated total cost not to exceed \$75,000.00, as part of the Capital Improvements Program for 2022-2027 by Resolution No. 2022-032; and

WHEREAS, the Board of Control, at its meeting held May 11, 2022, awarded a purchase contract with Shaw Industries, Inc., at State Term Pricing, for the replacement of carpet on the first floor and in the basement of the Domestic Relations Annex to the Courthouse, in an amount not to exceed \$68,322.32, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned purchase contract with Shaw Industries, Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a purchase contract with Shaw Industries, Inc., at State Term Pricing, for the replacement of carpet, on the first floor and in the basement of the Domestic Relations Annex to the Courthouse, in an amount not to exceed \$68,322.32, is hereby confirmed and the Executive is hereby authorized to execute said purchase contract and any other necessary related documents.

SECTION 2

This Resolution is declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further reason to immediately confirm the award of a necessary purchase contract for the replacement of carpet for the Clerk of Courts, on the first floor and in the basement of the Domestic Relations Annex as soon as practicable.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
