7 **An amended Resolution authorizing the Executive, on behalf of the Sheriff, to execute**
8 **mutual aid agreements with the cities of Tallmadge and Twinsburg as ~~entities~~ authorized**
9 **by section 302.21 of the Ohio Revised Code, for the Executive and Sheriff, and declaring an**
10 **emergency.**

12 WHEREAS, Section 302.21 of the Ohio Revised Code authorizes a county to enter into a
13 mutual aid agreement with any municipal corporation, township, port authority, water or sewer
14 district, school district, library district, health district, park district, soil and water conservation
15 district, water conservancy district, or other taxing district, or with the board of any other
16 county, to exercise any power, perform any function, or render any service, in behalf of the
17 contracting subdivision or its legislative authority, which such subdivision or legislative
18 authority may exercise, perform, or render; and

20 WHEREAS, in the interests of public safety throughout the County, the Executive, on
21 behalf of the Sheriff, wishes to be able to enter into such agreements with ~~such entities~~ the cities
22 of Tallmadge and Twinsburg upon request and proper legislative authorization by that entity
23 those cities; and

25 WHEREAS, the County and the City of Tallmadge wish to execute a Mutual Aid
26 Agreement for the provision of services by the Sheriff's Special Weapons and Tactics
27 ("SWAT") Unit; and

29 WHEREAS, the County and the City of Twinsburg wish to execute a Mutual Aid
30 Agreement for the provision of services by the County Sheriff's Major Crime Scene
31 Investigative Unit; and

33 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
34 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
35 execute mutual aid agreements with ~~entities~~ the cities of Tallmadge and Twinsburg as authorized
36 under Section 302.21 of the Ohio Revised Code;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:
