7 **A Resolution confirming the award by the Board of Control of a Temporary Assistance to**
8 **Needy Families Agreement with Emmanuel Christian Academy for Science Technology**
9 **Engineering Arts and Math (“STEAM”) Summer Enrichment Camp Services, from 5/1/22**
10 **through 8/31/22, in an amount not to exceed \$65,000.00, for the Executive’s Department of**
11 **Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Executive’s Department of Jobs (“DJFS”) wishes to enter into a
14 Temporary Assistance to Needy Families (“TANF”) agreement with Emmanuel Christian
15 Academy for Science Technology Engineering Arts and Math (“STEAM”) Summer Enrichment
16 Camp Services for up to eighty kindergarten through 8th grade students; and

17
18 WHEREAS, services provided will include academic, social and personal enrichment
19 opportunities designed to reinforce STEAM concepts learned during the school year, expand
20 general knowledge and social skills, and challenges students for the upcoming school year; and

21
22 WHEREAS, Emmanuel Christian Academy, in collaboration with Summit Education
23 Initiative, will assess students at the start and end of the program to determine its academic
24 effectiveness; and

25
26 WHEREAS, the Executive wishes to enter into a TANF Agreement with Emmanuel
27 Christian Academy to provide the above referenced services; and

29 WHEREAS, the Board of Control, at its meeting held May 18, 2022, awarded a TANF
30 Agreement with Emmanuel Christian Academy, which is exempt from competitive bidding due
31 to the provider’s subgrantee status, to provide STEAM Summer Enrichment Camp Services for
32 up to eighty kindergarten through 8th grade students, from 5/1/22 through 8/31/22, in an amount
33 not to exceed \$65,000.00, subject to confirmation by this Council; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that the aforementioned TANF Agreement with Emmanuel Christian Academy is necessary and
37 in the best interest of the County of Summit;

39 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that:

44 The award by the Board of Control of a Temporary Assistance to Needy Families
45 (“TANF”) Agreement with Emmanuel Christian Academy to provide Science Technology
46 Engineering Arts and Math (“STEAM”) Summer Enrichment Camp Services for up to eighty
47 kindergarten through 8th grade students, from 5/1/22 through 8/31/22, in an amount not to exceed
48 \$65,000.00, is hereby confirmed and the Executive is hereby authorized to execute said
49 agreement and any necessary related documents.
