7 **A Resolution confirming the award by the Board of Control of a purchase contract with**
8 **Federal Express Corporation for service of process of documents for the Clerk of Juvenile**
9 **Court for a total estimated amount not to exceed \$75,000.00 annually, for the Court of**
10 **Common Pleas-Juvenile Division, and declaring an emergency.**

12 WHEREAS, pursuant to 4.1 of the Ohio Rules of Civil Procedure, a Clerk of Courts may
13 utilize the services of a commercial carrier service to perform service of process of documents
14 that the Clerk is required to serve upon parties and others; and

15
16 WHEREAS, the County of Summit Clerk of Courts utilizes Federal Express Corporation
17 to perform service of process under certain circumstances; and

18
19 WHEREAS, the cost of service of process is generally paid by parties requesting the
20 service and is recovered through court costs; and

22 WHEREAS, the Board of Control awarded a contract to Federal Express Corporation for
23 service of process of documents at its meeting held on June 1, 2022; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned purchase contract with Federal Express Corporation is necessary and in
27 the best interest of the County of Summit;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 The award by the Board of Control of a purchase contract with Federal Express
35 Corporation, for service of process in Juvenile Cases for Juvenile Clerk of Courts for a total
36 amount not to exceed \$75,000.00 annually is hereby confirmed, and the Executive is hereby
37 authorized to execute said purchase contract and any other necessary related documents.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the residents of the County of Summit, and for the further purpose to immediately
43 provide service of process services for the Juvenile Clerk of Courts.


