7 **A Resolution authorizing the Executive to execute an agreement with Aurora Shores**
8 **Homeowners Association, Inc. for the acquisition of a permanent easement on Permanent**
9 **Parcel No. 6600021, located in the Village of Reminderville, in Council District 1, for a total**
10 **amount not to exceed \$2,770.00, as part of Pump Station #127, for the Executive's**
11 **Department of Sanitary Sewer Services, and declaring an emergency.**

13 WHEREAS, the acquisition of a permanent easement is necessary for drainage purposes
14 related to the operation of Pump Station #127, located in the Village of Reminderville, in
15 Council District 1; and

17 WHEREAS, AECOM Technical Services, Inc. and their subcontractor, Sours Buie and
18 Associates, LLC, on behalf of the Executive's Department of Sanitary Sewer Services, have
19 determined and negotiated the amount of a permanent easement for Permanent Parcel No.
20 6600021, which is real property owned by Aurora Shores Homeowners Association, Inc., in an
21 amount not to exceed \$2,770.00; and

23 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
24 is necessary and in the best interest of the County of Summit to authorize the Executive to
25 execute the aforementioned agreement for the acquisition of a permanent easement;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

30 SECTION 1

32 The Executive is hereby authorized to execute an agreement for the acquisition of a
33 permanent easement for Permanent Parcel No. 6600021 with Aurora Shores Homeowners
34 Association, Inc., the owner of said property, located in the Village of Reminderville, in Council
35 District 1, in an amount not to exceed \$2,770.00, as necessary for drainage purposes related to
36 the operation of Pump Station #127.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the residents of the County of Summit, and for the further reason that it immediately
42 authorizes the execution of the aforementioned agreement for the acquisition of an easement for
43 the operation of Pump Station #127.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.

10 121.05 of the Ohio Revised Code.


