 A Resolution authorizing the Executive to execute a grant agreement with the United Way of Summit and Medina for the Summit County Emergency Rental Assistance Program, to provide \$13,500,000.00, which will provide County residents with rental assistance, utility assistance and eviction prevention and declaring such expenditures necessary due to the continuing public health emergency with respect to the Coronavirus Disease 2019 (COVID-19), for the Executive, and declaring an emergency.

WHEREAS, the Coronavirus Disease 2019 (COVID-19) has had a significant impact on the health and wellbeing of County residents and has dramatically impacted many residents financially, rendering them unable to cover all of the normal expenses of living; and

WHEREAS, the County has received the sum of \$15,000,000.00 from the US Department of the Treasury as a result of the reallocation of Emergency Rental Assistance grant funds not spent by other jurisdictions to dedicate to the Program; and

WHEREAS, the County, the United Way of Summit and Medina (the "United Way"), Community Legal Aid, Fair Housing Contact Service, Mustard Seed Community Development Corporation, Asian Services In Action, Inc., International Institute of Akron, Akron Metropolitan Housing Authority, the Summit County Department of Community and Economic Development and Community Action Akron Summit and the Battered Women's Shelter of Summit and Medina Counties partnered to establish a rent and utility assistance program geared toward ensuring that County residents who have been thus impacted are able to remain in their place of residence (the "Program"); and

WHEREAS, this Council previously adopted Resolution No. 2021-061, which established the Summit County Emergency Rental Assistance Program and authorized a grant agreement with the United Way and various community partners in an amount not to exceed \$16,149,837.80 to fund the Program; and

WHEREAS, this Council subsequently adopted Resolution No. 2021-284, which authorized the Executive to execute grant agreements in an amount not to exceed \$1,550,000.00 for phase two of the Summit County Emergency Rental Assistance Program to assist Summit County residents with rental assistance, utility assistance, eviction prevention, data collection, lender negotiation, financial counseling and other services necessary to allow residents to remain in their place of residence; and

WHEREAS, this Council subsequently adopted Resolution No. 2022-059, which authorized the Executive to spend an amount not to exceed \$213,173.00 to fund the administration of the Program by the Executive's Department of Community and Economic Development, which will complete the review of applications for funds and prepare vouchers to be sent to the United Way for payment. Pursuant to Resolution No. 2022-059, the Executive was authorized to execute an agreement with the United Way in an amount not to exceed \$30,000.00 in Program funds for its role in administering the Program which will include processing check vouchers for utility providers and landlords; and

WHEREAS, from the \$15,000,000.00 reallocation, the Executive wishes to execute a grant agreement with the United Way for the Summit County Emergency Rental Assistance Program, to provide \$13,500,000.00 to the United Way, which will provide County residents with rental assistance, utility assistance and eviction prevention, with an amount not to exceed \$1,500.000.00 held to fund the administration of the Program by the United Way and the Executive's Department of Community and Economic Development, which will continue to review applications for funds and prepare vouchers to be sent to the United Way for payment; and

WHEREAS, this Council finds and determines after reviewing all pertinent information that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned grant agreement with United Way to grant funds to the Program; and

WHEREAS, this Council further finds and determines, after reviewing all pertinent information, that the expenditure is necessary for services related to the Program which continues to be necessary due to the public health emergency created by the COVID-19 pandemic, and is being done in compliance with the provisions of Section 501 of the federal Consolidated Appropriations Act, 2021;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

## SECTION 1

 The Executive is hereby authorized to execute the grant agreement with United Way Summit and Medina in an amount not to exceed \$13,500,000.00, in order to provide County residents with rental, utility assistance and eviction prevention as a part of the Summit County Emergency Rental Assistance Program. The Executive is hereby authorized to spend an amount not to exceed \$1,500,000.00, from the total grant amount of \$15,000.000.00 to fund the administration of the Program to be divided between the United Way and the Executive's Department of Community and Economic Development and authorizing the Executive to execute an additional grant to the United Way from the administration funds upon determination of the amount needed for that purpose.

## **SECTION 2**

This Council finds and declares that such expenditure is necessary due to the continuing public health emergency created by the COVID-19 pandemic and is being done in compliance with the provisions of Section 501 of the federal Consolidated Appropriations Act, 2021.

## **SECTION 3**

This Resolution is declared an emergency in the interest of the health, safety, and welfare of the residents of the County of Summit, and for the further reason to immediately authorize the provision of services related to the Summit County Emergency Rental Assistance Program to Summit County residents that have been negatively impacted by the COVID-19 pandemic.
