WHEREAS, at its meeting held June 16, 2022, at the request of the Department of Human Resources the Child Support Enforcement Agency, the Human Resource Commission approved the upgrading of the classification and classification specification for the non-bargaining classified position of Child Support Supervisor, Pay Grade 5 to Child Support Supervisor, Category 2, Pay Grade 8, as stated in Order 22-02, a copy of which is attached hereto as Exhibit A and incorporated fully herein; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to approve the upgrading of the classification and classification specification by the Human Resource Commission for the non-bargaining classified position of Child Support Supervisor, Class Code 29703, Category 2, Pay Grade 5 to Child Support Supervisor, Category 2, Pay Grade 8;
