7 **A Resolution approving the upgrade of the classification and classification specification by**
8 **the Human Resource Commission for the non-bargaining classified position of Child**
9 **Support Supervisor, for the Executive's Department of Human Resources and the**
10 **Prosecutor, and declaring an emergency.**

12 WHEREAS, this Council has the authority pursuant to Article III, Section 3.03 (10) of
13 the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
14 Codified Ordinances of the County of Summit to establish classifications and classification
15 specifications for all County employees; and

17 WHEREAS, the Executive's Department of Human Resources and the Prosecutor
18 through her Child Support Enforcement Agency, recently conducted a review and revision of the
19 duties associated with this classification specification of Child Support Supervisor, Class Code
20 29703; and

22 WHEREAS, as a result of the review, the Department of Human Resources and the Child
23 Support Enforcement Agency request the following title and pay grade revision:

29 WHEREAS, at its meeting held June 16, 2022, at the request of the Department of
30 Human Resources the Child Support Enforcement Agency, the Human Resource Commission
31 approved the upgrading of the classification and classification specification for the non-
32 bargaining classified position of Child Support Supervisor, Pay Grade 5 to Child Support
33 Supervisor, Category 2, Pay Grade 8, as stated in Order 22-02, a copy of which is attached hereto
34 as Exhibit A and incorporated fully herein; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that it is necessary and in the best interest of the County of Summit to approve the upgrading of
38 the classification and classification specification by the Human Resource Commission for the
39 non-bargaining classified position of Child Support Supervisor, Class Code 29703, Category 2,
40 Pay Grade 5 to Child Support Supervisor, Category 2, Pay Grade 8;

31 121.22 of the Ohio Revised Code.


