8 **A Resolution approving the salary adjustment for classified non-bargaining**

10 WHEREAS, the Engineer wishes to grant a salary adjustment for classified non-  
11 bargaining employee Deborah Atkins, who has assumed additional administrative duties as a  
12 result of the recent adoption of an expanded Summit County Surface Water Management  
13 District; and

15 WHEREAS, because the salary adjustment for the aforementioned employee represents a  
16 pay increase under Section 169.07 of the Codified Ordinances of the County of Summit, this  
17 Council's approval of salary adjustments is required; and

19 WHEREAS, the Director of the Department of Human Resources will review the  
20 personnel action for the aforementioned salary adjustment as required by Section 169.07(b) of  
21 the Codified Ordinances; and

23 WHEREAS, the salary adjustment will be submitted to the Director of the Department of  
24 Finance and Budget for certification of availability of appropriated funds, as required by Section  
25 169.07(b) of the Codified Ordinances; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that the  
28 aforementioned salary adjustment is necessary and in the best interest of the County of Summit;


