7 **A Resolution approving the 2022 wage reopener as agreed between the County of Summit**  
8 **and Local 1229 of the American Federation of State, County and Municipal Employees,**  
9 **AFL-CIO (Legal Division of Clerk of Courts), for the second year of the parties' Collective**  
10 **Bargaining Agreement, from 4/1/22 through 3/31/23, for the Executive and the Clerk of**  
11 **Courts, and declaring an emergency.**

12  
13 WHEREAS, pursuant to Resolution No. 2021-189, a Collective Bargaining Agreement  
14 and Memorandum of Understanding were approved between Ohio Council 8 and Local 1229  
15 (Legal Division of Clerk of Courts) of the American Federation of State, County and Municipal  
16 Employees, AFL-CIO (collectively, the "Union"), and the Executive and the Clerk of Courts, for  
17 the period 4/1/21 through 3/31/24, with a reopener on wages in the second and third year of the  
18 agreement (4/1/2022 and 4/1/2023); and

20 WHEREAS, the Executive and the Union have reached an agreement on the 2022 wage  
21 reopener with an increase in pay of two and one-half percent (2.5%) in the second year of the  
22 agreement (effective 4/1/2022); and

23  
24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County to approve the wage reopener between  
26 the Union and the Executive and the Engineer, as agreed between the parties;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that:

31 SECTION 1

33 The agreement on the wage reopener between Ohio Council 8 and Local 1032 (Legal  
34 Division of Clerk of Courts) of the American Federation of State, County and Municipal  
35 Employees, AFL-CIO, for the second year of the Collective Bargaining Agreement, effective  
36 April 1, 2022, is hereby approved, authorizing an increase in pay of two and one-half percent  
37 (2.5%).

39 SECTION 2

41 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
42 welfare of the residents of the County of Summit and for the for the further purpose of providing  
43 a timely wage increase for Local 1229 (Legal Division of Clerk of Courts) of the American  
44 Federation of State, County and Municipal Employees, AFL-CIO.

16 121.22 of the Ohio Revised Code.


