7 **A Resolution certifying Special Surface Water Management District charges to the Fiscal**
8 **Officer, for the Engineer, and declaring an emergency.**

10 WHEREAS, Section 942.14 of the County of Summit Codified Ordinances sets forth the
11 rate schedule for the Special Surface Water Management District (Bath Township) and the
12 Engineer's Office has determined the charges due for each parcel within the Special District for
13 the current July to June billing cycle; and

14
15 WHEREAS, Section 942.15 of the County of Summit Codified Ordinances provides that
16 these charges are to be placed on the property tax duplicate for collection by certification of such
17 amounts to the Fiscal Officer in August; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that it is necessary and in the best interest of the County of Summit to certify the aforementioned
21 charges to the Fiscal Officer.

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
24 of Ohio, that;

28 The Special Surface Water Management District charges listed in Exhibit A, attached to
29 this Resolution and incorporated herein as if fully restated, are hereby certified to the Fiscal
30 Officer to be placed on the tax list and duplicate for each respective parcel for collection as other
31 taxes are collected.

35 The Clerk of Council shall deliver a copy of this Resolution to the Fiscal Officer who
36 shall process the Special Surface Water Management Service Charges set forth in Exhibit A for
37 collection pursuant to the County of Summit Codified Ordinances.

41 This Resolution is hereby declared an emergency in the interest of the health, safety, and
42 welfare of the residents of the County of Summit, and for the further reason to immediately
43 ensure the certification of charges to the Fiscal Officer.

47 Provided this resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.


