7 **A Resolution authorizing the Executive to enter into agreements for the acquisition of**  
8 **standard highway and temporary easements at 2700 and 2813 Myersville Road, located in**  
9 **Springfield Township, in Council District 8, in a total amount not to exceed \$7,939.00, as**  
10 **part of the Pressler Road Bridge Replacement Project for the Engineer, and declaring an**  
11 **emergency.**

13 WHEREAS, there is a public need to replace the Pressler Road Bridge over the South  
14 Fork of the Tuscarawas River, and the County intends to undertake the Pressler Road Bridge  
15 Replacement Project (the "Project"), located in Springfield Township, in Council District 8; and

16  
17 WHEREAS, certain land must be acquired by the County to be utilized as public right-of-  
18 way as part of the Project; and

19  
20 WHEREAS, acquisition of lands for public right-of-way for the Project is considered a  
21 local cost, which must be borne in whole by the local public agency performing the Project, in  
22 this case being the County of Summit; and

24 WHEREAS, the County has negotiated terms for agreements for the acquisition of  
25 standard highway and temporary easements at 2700 and 2813 Myersville Road, located in  
26 Springfield Township, in Council District 8, to serve as the necessary public right-of-way for the  
27 Project; and

29 WHEREAS, this Council has determined, after reviewing all pertinent information, that it  
30 is necessary and in the best interest of the County of Summit to authorize the Executive to  
31 execute the aforementioned agreements for the acquisition of standard highway and temporary  
32 easements;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
35 of Ohio, that;

39 The Executive is hereby authorized to execute agreements and any necessary related  
40 documents for the acquisition of standard highway easements and temporary easements at 2700  
41 Myersville Road, and standard highway easements at 2813 Myersville Road, located in  
42 Springfield Township, in Council District 8, in a total amount not to exceed \$7,939.00, as part of  
43 the Pressler Road Bridge Replacement Project (the "Project"), with the owners of said property,
