7 **A Resolution confirming the award by the Board of Control of professional service**
8 **contracts with certain providers for State Fiscal Year 2023 Temporary Assistance to Needy**
9 **Families funded services, from 10/1/22 through 9/30/23, in a total amount not to exceed**
10 **\$1,720,000.00, for the Executive's Department of Job and Family Services, and declaring**
11 **an emergency.**

13 WHEREAS, the Executive wishes to enter into professional service contracts with ten
14 providers to provide Temporary Assistance to Needy Families ("TANF") funded services, a list
15 of which is set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully
16 restated; and

18 WHEREAS, the Board of Control, at its meeting held August 24, 2022, awarded
19 professional service contracts with certain providers, which are exempt from competitive bidding
20 due to the providers' subgrantee status, for State Fiscal Year 2023 TANF funded services, from
21 10/1/22 through 9/30/23, in a total amount not to exceed \$1,720,000.00, subject to confirmation
22 by this Council; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information
25 that the aforementioned professional service contracts with certain providers set forth in Exhibit
26 A are necessary and in the best interest of the County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The award by the Board of Control of professional service contracts with certain
34 providers, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully
35 restated, for the State Fiscal Year 2023 Temporary Assistance to Needy Families ("TANF")
36 funded services, from 10/1/22 through 9/30/23, in a total amount not to exceed \$1,720,000.00,
37 are hereby confirmed and the Executive is hereby authorized to execute said professional service
38 contracts and any other necessary related documents.

42 This Resolution is hereby declared an emergency in the interest of the health, safety and
43 welfare of the residents of the County of Summit, and for the further reason to immediately
44 authorize the Executive to execute the aforementioned professional service contracts in order to
45 enable to providers to provide necessary services as expeditiously as possible.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take
50 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
51 effect and be in force at the earliest time provided by law.



10 121.22 of the Ohio Revised Code.


