7 **A Resolution authorizing the Executive to advertise for bids for the Christman Road**
8 **Bridge over the Nimisila Reservoir Replacement Project, located in the City of Green, in**
9 **Council District 8, for an estimated total cost not to exceed \$1,455,000.00, for the Engineer**
10 **and declaring an emergency.**

11
12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the Executive to advertise for bids; and

14
15 WHEREAS, the Christman Road Bridge over the Nimisila Reservoir, structure number
16 GRT-239-0104, is in critical condition and in need of replacement; and

17
18 WHEREAS, due to the critical condition of the structure, the Christman Road Bridge
19 over the Nimisila Reservoir has been closed to motor vehicle traffic since June 10, 2022, and as a
20 result, the design process has been expedited to get the bridge replaced and reopened as soon as
21 possible; and

23 WHEREAS, the Engineer estimates the cost of the bridge replacement to be
24 \$1,455,000.00; and

25
26 WHEREAS, pursuant to Resolution No. 2020-389, which authorized the Executive to
27 enter into an intergovernmental agreement with the City of Green, the City is partnering with the
28 County on this project and the new bridge will include a 12 foot-wide multi-purpose walkway to
29 integrate with a planned trail in the City of Green; and

31 WHEREAS, the Christman Road Bridge over the Nimisila Reservoir Bridge
32 Replacement Project (Project Identification Number 113945) has received 100% federal funding
33 programmed through County Engineer's Association of Ohio's Local Bridge Program up to
34 \$1,172,000.00, with the remaining cost to be paid equally by the County and City of Green; and

36 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
37 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
38 advertise for bids for the Christman Road Bridge over the Nimisila Reservoir Replacement
39 Project;

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
42 of Ohio, that:

46 The Executive is hereby authorized to advertise for the Christman Road Bridge over the
47 Nimisila Reservoir Replacement Project, located in the City of Green, in Council District 8, at a
48 cost not to exceed \$1,455,000.00.

6 This Resolution is hereby declared an emergency in the interest of the health, safety, and
7 welfare of the residents of the County of Summit, and for the further reason that it will allow the
8 County to replace a closed bridge in an expedited fashion.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,
21 were in meetings open to the public, in compliance with all legal requirements, including Section
22 121.22 of the Ohio Revised Code.
