WHEREAS, the Executive wishes to enter into a professional service contract with Tyler Technologies, Inc. for its Eagle Recorder software application, which the County has used since 2015; and

WHEREAS, due to the County's past uses of the Eagle Recorder application and Tyler Technologies, Inc.'s understanding of the technical aspects of the application and specific knowledge of the Fiscal Office's Recorders Division, Tyler Technology, Inc. is a Best Practical Source pursuant to Sections 177.01(h)(4)D. and 177.07(a)(5) of the Codified Ordinances of the County of Summit, and as such is exempt from competitive bidding; and

WHEREAS, the Board of Control, at its meeting held September 21, 2022, awarded a professional service contract with Tyler Technologies, Inc., as a Best Practical Source, subject to ratification by the Information Technology Board, for annual software support and maintenance fees for the Eagle Recorder software application for the Fiscal Officer's Recorder's Division, for the period of 12/1/22 to 11/30/23, in an amount not to exceed \$103,925.16, subject to confirmation by this Council; and

WHEREAS, the aforementioned purchase contract with Tyler Technologies, Inc., approved by the Board of Control as a Best Practical Source, will be presented to the Information Technology Board at its meeting to be held October 13, 2022; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Tyler Technologies, Inc., subject to ratification by the Information Technology Board, is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
