7 **A Resolution approving the establishment of the classification and classification**
8 **specification of Deputy Sheriff Cadet, and revising the Sheriff's classified salary schedule**
9 **to include the classified position of Deputy Sheriff Cadet, Class Code 40075, for the Sheriff**
10 **and the Executive's Department of Human Resources, and declaring an emergency.**

12 WHEREAS, this Council has the authority pursuant to Article III, Section 3.03(10) of the
13 Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
14 Codified Ordinances of the County of Summit to establish classifications and classification
15 specifications for all County employees; and

16
17 WHEREAS, the Sheriff wishes to revise her classified salary schedule to include a newly
18 established classified position of Deputy Sheriff Cadet, Class Code 40075, Category C2; Pay
19 Grade 3; and

20
21 WHEREAS, the classification of Deputy Sheriff Cadet will be a temporary position
22 designed to encourage recruitment of Deputy Sheriffs, and will be assigned to attend and
23 participate in the University of Akron/Summit County Sheriff's Office Police Academy (the
24 "Academy"); and

25
26 WHEREAS, Deputy Sheriff Cadets will be hired as Deputy Sheriffs with the Sheriff's
27 Office upon successful completion of the Academy; and

29 WHEREAS, at its meeting held on October 19, 2022, at the request of the Executive's
30 Department of Human Resources and the Sheriff, the Human Resource Commission approved
31 the establishment of the classification and classification specification for the non-bargaining
32 classified position of Deputy Sheriff Cadet, Class Code 40075, Category C2; Pay Grade 3, a
33 copy of which is attached hereto as Exhibit A and incorporated fully herein; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 it is necessary and in the best interest of the County of Summit to approve the classification of
37 Deputy Sheriff Cadet, and revise the Sheriff's classified salary schedule to include said
38 classification;

40 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
41 of Ohio, that:

46 Resource Commission, a copy of which is attached hereto as Exhibit A and incorporated fully
47 herein, for the non-bargaining classified position of Deputy Sheriff Cadet is hereby confirmed

13 This Resolution is hereby declared an emergency in the interest of the health, safety and
14 welfare of the residents and employees of the County of Summit, and for the further reason that
15 it is necessary to immediately allow the Sheriff to promote recruitment of deputies within her
16 office.

20 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
22 effect and be in force at the earliest time provided by law.

27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
