7 **A Resolution authorizing the Executive to advertise for bids for a Rescue Tech training**  
8 **series, for the Type II Ohio Region 5 Confined Search and Rescue Team, for a total cost not**  
9 **to exceed \$106,296.00, for the Executive's Department of Public Safety, Emergency**  
10 **Management Agency and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires  
13 this Council's authorization for the Executive to advertise for bids; and

14  
15 WHEREAS, the Executive wishes to advertise for bids for a Rescue Tech training series  
16 for the Type II Ohio Region 5 Confined Search and Rescue Team for an estimated total cost not  
17 to exceed \$106,296.00; and

19 WHEREAS, said training will be fully grant-funded; and

21 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
24 that is necessary and in the best interest of the County of Summit to authorize the Executive to  
25 advertise for bids for a Rescue Tech training series for the Type II Ohio Region 5 Confined Search  
26 and Rescue Team;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that;

33 The Executive is hereby authorized to advertise for bids for a Rescue Tech training series  
34 for the Type II Ohio Region 5 Confined Search and Rescue Team, for an estimated total cost not  
35 to exceed \$106,296.00.

39 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
40 of the residents of the County of Summit, and for the further reason that it authorizes the Executive  
41 to immediately advertise for bids in order to procure the necessary training within the grant  
42 performance period.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take effect  
47 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and  
48 be in force at the earliest time provided by law.

10 of the Ohio Revised Code.


