7 **A Resolution authorizing the Executive to advertise for bids for sixteen (16) self-contained**
8 **breathing apparatus (SCBA) units, twenty (20) SCBA facepieces, forty-two (42) SCBA**
9 **bottles and accessories for the Summit County Type I HazMat Team, for a total cost not to**
10 **exceed \$235,000.00, for the Executive's Department of Public Safety, Emergency**
11 **Management Agency and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit requires
14 this Council's authorization for the Executive to advertise for bids; and

15
16 WHEREAS, the Executive wishes to advertise for bids for sixteen (16) self-contained
17 breathing apparatus (SCBA) units, twenty (20) SCBA facepieces, forty-two (42) SCBA bottles
18 and accessories for the Summit County Type I HazMat Team, for an estimated total cost not to
19 exceed \$235,000.00; and

21 WHEREAS, said equipment will be fully grant-funded; and

23 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that is necessary and in the best interest of the County of Summit to authorize the Executive to
27 advertise for bids the aforementioned equipment for the Summit County Type I Hazmat Team;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that;

32 SECTION 1

34 The Executive is hereby authorized to advertise for bids for sixteen (16) self-contained
35 breathing apparatus (SCBA) units, twenty (20) SCBA facepieces, forty-two (42) SCBA bottles
36 and accessories for the Summit County Type I HazMat Team, the Summit County Type I Hazmat
37 Team for an estimated total cost not to exceed \$235,000.00.

41 This Resolution is declared an emergency in the interest of the health, safety, and welfare
42 of the residents of the County of Summit, and for the further reason that it authorizes the Executive
43 to immediately advertise for bids in order to procure the necessary equipment within the grant
44 performance period.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take effect
49 immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and
50 be in force at the earliest time provided by law.

10 of the Ohio Revised Code.


