A Resolution amending Resolution No. 2020-041 to change the contract period to a five-year Master Services Agreement, 1/1/20 through 12/31/24, for a professional service contract with Effectiff Services to act as a broker for translation and interpreter services for non-English-speaking clients, and approving the pricing list for said services, for the Executive, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2020-041, which authorized the Executive to enter into a Master Services Agreement with Effectiff Services to act as a broker for translation and interpreter services for non-English-speaking clients, for the period of 1/1/20 to 12/31/20, with two options to renew for an additional one-year term, and approved for the price list for said services, which is attached to this Resolution as Exhibit A and incorporated herein as if fully restated; and

WHEREAS, the County's original Request for Proposals for translating services and Effectiff's proposal were written to cover a five-year period, giving County Offices, Summit County local governments and local non-profits the ability to avail themselves of those services at the agreed prices, however Resolution 2020-041 only authorized a one year Master Services Agreement with 2 one-year renewals; and

WHEREAS, the parties of said Master Services Agreement wish to lock in the rates, as listed in Exhibit A, for the full five-year period, and increase efficiency and cost savings by obtaining approval for a five-year contract period; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to amend Resolution No. 2020-041 as stated above;
