7 **A Resolution authorizing Summit County, including offices therein, to become members of**
8 **the newly created Community, University, Education Council of Governments (CUE-**
9 **COG), established October 18, 2022, as initial political subdivisions eligible to join**
10 **pursuant to the bylaws of the CUE-COG, and declaring an emergency.**

12 WHEREAS, multiple Summit County offices were members of Community, University,
13 Education (CUE), a non-profit organization dedicated to finding the best sources for materials,
14 such as road salt and diesel fuel, for political subdivisions; and

15
16 WHEREAS, on November 7, 2022, the Chairperson of the CUE Steering Committee
17 invited current members of the CUE to join the newly created Community, University,
18 Education Council of Governments (CUE-COG) these members included the County Engineer,
19 Summit County Metro Parks, and the Summit County Developmental Disabilities Board; and

21 WHEREAS, the County desires to accept the invitation and join the CUE-COG in order
22 to obtain quality merchandise, materials and services for its members at lower cost through
23 pooled purchasing and competitive bidding; and

25 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
26 that it is necessary and in the best interest of the County of Summit to join the CUE-COG;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that:

33 The Executive is hereby authorized to execute documents necessary for memberships
34 into the CUE-COG.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the residents and employees of the County of Summit.

43 Provided this Resolution receives the affirmative vote of eight (8) members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
