7 **A Resolution confirming the award by the Board of Control of a five-year purchase**
8 **contract with AXON Enterprise, Inc., at Sourcewell pricing, for the purchase of body worn**
9 **cameras, tasers, related supplies, a warranty and software, in an amount not to exceed**
10 **\$1,764,861.30, for the Sheriff, and declaring an emergency.**

12 WHEREAS, the current body worn cameras and tasers used by the Sheriff are becoming
13 outdated and in need of replacement; and

14
15 WHEREAS, the Sheriff seeks to enter into a five-year purchase contract with AXON
16 Enterprise, Inc., at Sourcewell pricing, for the purchase of body worn cameras, tasers, related
17 supplies, a warranty and software, for the Sheriff, in an amount not to exceed \$1,764,861.30; and

18
19 WHEREAS, the Board of Control, at its meeting held November 16, 2022, awarded,
20 subject to the approval of the Information Technology Board, a five-year purchase contract with
21 AXON Enterprise, Inc., at Sourcewell pricing, for the purchase of body worn cameras, tasers,
22 related supplies, a warranty and software, in an amount not to exceed \$1,764,861.30, subject to
23 confirmation by this Council; and

25 WHEREAS, the Information Technology Board, at its meeting held on November 17,
26 2022, ratified the aforementioned purchase contract with AXON Enterprise, Inc.; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
29 that the aforementioned purchase contract with AXON Enterprise, Inc. is necessary and in the
30 best interest of the County of Summit;

32 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The award by the Board of Control of a five-year purchase contract with AXON
38 Enterprise, Inc., at Sourcewell pricing, approved by the Information Technology Board on
39 November 17, 2022, for the purchase of body worn cameras, tasers, related supplies, a warranty
40 and software, for the Sheriff, in an amount not to exceed \$1,764,861.30, is hereby confirmed and
41 the Executive is hereby authorized to execute said purchase contract and any other necessary
42 related documents.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the residents of the County of Summit, and for the further reason to immediately
48 authorize the purchase of necessary body worn cameras, tasers and related materials for the
49 safety of the community.

16 121.22 of the Ohio Revised Code.


