7 **A Resolution confirming the award by the Board of Control of a renewal (second and final)**
8 **of a professional service contract with KeyBank, National Association to provide bank**
9 **depository and remittance lock box services, for a two-year term, from 1/1/23 to 12/31/24,**
10 **in a total amount not to exceed \$187,645.22, for the Fiscal Officer, and declaring an**
11 **emergency.**

13 WHEREAS, this Council previously adopted Resolution No. 2018-431, which confirmed
14 the award by the Board of Control of a professional service contract with KeyBank, National
15 Association to provide bank depository and remittance lock box services, for a two-year term,
16 from 1/1/19 to 12/31/20, with two options to renew for an additional two-year term, in a total
17 amount not to exceed \$187,645.22; and

19 WHEREAS, this Council subsequently adopted Resolution No. 2020-374, which
20 confirmed the award by the Board of Control of a renewal (first of two) of a professional service
21 contract with KeyBank, National Association to provide bank depository and remittance lock
22 box services, for a two-year term, from 1/1/21 to 12/31/22, in a total amount not to exceed
23 \$187,645.22; and

25 WHEREAS, the Board of Control, at its meeting held November 16, 2022, awarded a
26 renewal (second and final) of the aforementioned professional service contract with KeyBank,
27 National Association for a two-year term, from 1/1/23 to 12/31/24, in a total amount not to
28 exceed \$187,645.22, subject to confirmation by this Council; and

30 WHEREAS, this Council finds and determines after reviewing all pertinent information,
31 that the aforementioned renewal of the professional service contract with KeyBank, National
32 Association is necessary and in the best interest of the County of Summit;

34 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The award by the Board of Control of a renewal (second and final) of a professional
40 service contract with KeyBank, National Association to provide bank depository and remittance
41 lock box services, for a two-year term, from 1/1/23 to 12/31/24, in a total amount not to exceed
42 \$187,645.22, is hereby confirmed and the Executive is hereby authorized to execute said renewal
43 of a professional service contract and any other necessary related documents.

49 provide for a necessary professional service contract for bank depository and remittance lock box
