WHEREAS, this Council subsequently adopted Resolution No. 2020-374, which confirmed the award by the Board of Control of a renewal (first of two) of a professional service contract with KeyBank, National Association to provide bank depository and remittance lock box services, for a two-year term, from 1/1/21 to 12/31/22, in a total amount not to exceed \$187,645.22; and

WHEREAS, the Board of Control, at its meeting held November 16, 2022, awarded a renewal (second and final) of the aforementioned professional service contract with KeyBank, National Association for a two-year term, from 1/1/23 to 12/31/24, in a total amount not to exceed \$187,645.22, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned renewal of the professional service contract with KeyBank, National Association is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

 The award by the Board of Control of a renewal (second and final) of a professional service contract with KeyBank, National Association to provide bank depository and remittance lock box services, for a two-year term, from 1/1/23 to 12/31/24, in a total amount not to exceed \$187,645.22, is hereby confirmed and the Executive is hereby authorized to execute said renewal of a professional service contract and any other necessary related documents.
