7 **A Resolution approving and adopting the 2023 operating budget for all funds, departments**
8 **and agencies of the County of Summit and appropriating funds totaling \$534,495,088.00 as**
9 **set forth in Exhibit A, for the Executive's Department of Finance and Budget, and**
10 **declaring an emergency.**

11
12 WHEREAS, this Council's duties include the adoption of an annual operating budget for
13 the County of Summit; and

14
15 WHEREAS, this Council has determined by reviewing all pertinent information that
16 approving and adopting the 2023 full operating budget for all funds, departments and agencies of
17 the County of Summit, as set forth in Exhibit A, attached to this Resolution and incorporated
18 herein as if fully restated, is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

23 SECTION 1

24
25 The 2023 full operating budget for all funds, departments and agencies for the County of
26 Summit, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully
27 restated is hereby approved and adopted.

28
29 SECTION 2

30
31 This Resolution will constitute approval for the Fiscal Officer to do any of the following
32 for the 2023 fiscal year:

- 33
34 (a) Make any of the following interfund transfers and/or advances:
- 35
 - 36 (1) Transfer and/or advance money from the General Fund to any other fund
 - 37 of the County and repay money from any fund receiving an advance, back
 - 38 to the General Fund.
 - 39
 - 40 (2) Transfer money to any internal service fund from any other fund of the
 - 41 County from which the obligations being paid by that internal service fund
 - 42 are properly payable and transfer money from any internal service fund
 - 43 back to the appropriate fund.
 - 44
- 45 (b) If this Resolution is enacted with the affirmative vote of two-thirds of the
- 46 members of this Council, make any of the following interfund transfers:
 - 47
 - 48 (1) Transfer the unexpended balance in a bond fund that is no longer needed
 - 49 for the purpose for which that fund was created to the Bond Retirement
 - 50 Fund.

4 (2) Transfer the unexpended balance in any specific permanent improvement
5 fund, other than a bond fund, after the payment of all obligations incurred
6 in the acquisition of that improvement:

8 (A) To the Bond Retirement Fund, or

9
10 (B) If that money is not required to meet the obligations payable from
11 the Bond Retirement Fund, to a special fund for the acquisition of
12 permanent improvements, including the Capital Projects Fund, or
13 with the approval of the Summit County Court of Common Pleas,
14 to the General Fund.

15
16 (3) Transfer the unexpended balance in any special fund, other than an
17 improvement fund, to the General Fund or to the Bond Retirement Fund
18 after the termination of the activity, service, or other undertaking for
19 which that special fund existed, but only after the payment of all
20 obligations incurred and payable from that special fund.

21
22 (4) Transfer moneys retained or received under Section 4501.04 or Section
23 5735.27(A)(3), Revised Code (relating to motor vehicle and motor fuel
24 taxes, respectively) to the Bond Retirement Fund if any principal, interest,
25 or charges for which those moneys may be used are payable from the
26 Bond Retirement Fund.

28 (c) Create new funds in the County's chart of accounts as needed.

29
30 SECTION 3

31
32 The Fiscal Officer is hereby authorized and directed to effect the within appropriations as
33 set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated.

35 SECTION 4

36
37 For Fiscal Year 2023, each member of the County of Summit Human Resource
38 Commission shall be compensated at a bi-weekly rate of \$354.52, with no fringe benefits, to be
39 paid in 26 equal payments.

41 SECTION 5

42
43 The Executive's Department of Finance and Budget shall submit to this Council a report
44 of actual monthly revenues and expenditures for each County department, office, agency,
45 authority, board and commission on an annual basis, to be in compliance with Section 2.03(8)(c)
46 of the Codified Ordinances of the County of Summit.

13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
14 effect and be in force at the earliest time provided by law.

19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,

22 121.22 of the Ohio Revised Code.
