12 WHEREAS, this Council's duties include the adoption of an annual operating budget for  
13 the County of Summit; and

15 WHEREAS, this Council has determined by reviewing all pertinent information that  
16 approving and adopting the 2023 full operating budget for the Executive's Department of Job  
17 and Family Services, as set forth in Exhibit A, attached to this Resolution and incorporated  
18 herein as if fully restated, is necessary and in the best interest;

24 The 2023 full operating budget for the Executive's Department of Job and Family  
25 Services, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully  
26 restated is hereby approved and adopted.

30 The Fiscal Officer is hereby authorized and directed to effect the within appropriations as  
31 set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and  
36 welfare of the residents of the County of Summit and for the further reason that the  
37 appropriations contained in Exhibit A are immediately needed for operations of the Executive's  
38 Department of Job and Family Services.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take  
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating  
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
50 deliberations of this Council and of any of its committees that resulted in such formal action,

52 121.22 of the Ohio Revised Code.
