7 **A Resolution authorizing the Executive to advertise for bids as needed for bridge**
8 **engineering and construction projects, pavement maintenance projects for the Engineer's**
9 **2023 Capital Improvement Program at an estimated cost not to exceed \$13,962,800.00 for**
10 **the Engineer, and declaring an emergency.**

11
12 WHEREAS, this Council will be asked to authorize a 2023 Capital Improvements
13 Program budget at or near the beginning of the year 2023, which will include highway and
14 bridge improvements for the Engineer; and

15
16 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
17 requires this Council's authorization for the Executive to advertise for bids for said
18 improvements; and

19
20 WHEREAS, advertising construction projects in January and February has resulted in
21 lower costs and more competition among bidders in past years; and

22
23 WHEREAS, this Council will also award the contracts for each of the projects by
24 separate legislation; and

26 WHEREAS, the total estimated cost of the aforementioned projects is \$13,962,800.00;

29 WHEREAS, this Council has determined by reviewing all pertinent information that is
30 necessary and in the best interest of the County of Summit that the Executive be authorized to
31 advertise for bids as necessary for bridge engineering and construction projects and pavement
32 maintenance projects for the County Engineer's 2023 Capital Improvements Program and federal
33 and state funded projects, for an estimated cost not to exceed \$13,962,800.00, subject to the
34 appropriation of funds;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
