7 **A Resolution confirming the award by the Board of Control of a construction contract with**
8 **Ohio Paving and Construction Co., Inc., for the Paving Improvement Project, for the**
9 **parking lot at the Summit County Children Services Administration Building, located in**
10 **the City of Akron, in Council District 4, in an amount not to exceed \$233,666.00, for the**
11 **Executive's Department of Administrative Services-Physical Plants, and declaring an**
12 **emergency.**

14 WHEREAS, this Council previously adopted Resolution No. 2022-294, which authorized
15 the Executive to advertise for bids for the Paving Improvement Project, for the parking lot at the
16 Summit County Children Services Administration Building (the "Project"), located in the City of
17 Akron, in District 4, for a total not to exceed \$314,000.00; and

18
19 WHEREAS, after receiving five responses, the Executive selected Ohio Paving and
20 Construction Co., Inc. was the lowest responsive and responsible bidder with a bid of
21 \$233,666.00; and

23 WHEREAS, the Board of Control, at its meeting held on November 23, 2022, awarded
24 the aforementioned construction contract with Ohio Paving and Construction Co., Inc., as the
25 lowest responsive and responsible bidder, for the Project, in an amount not to exceed
26 \$233,666.00, subject to confirmation by this Council; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information
29 that the aforementioned construction contract with Ohio Paving and Construction Co., Inc. is
30 necessary and in the best interest of the County of Summit;

32 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The award by the Board of Control of a construction contract with Ohio Paving and
38 Construction Co., Inc., for the Paving Improvement Project, for the parking lot at the Summit
39 County Children Services Administration Building (the "Project"), located in the City of Akron,
40 in Council District 4, in an amount not to exceed \$233,666.00, is hereby confirmed, and the
41 Executive is hereby authorized to execute said construction contract and any other necessary
42 related documents.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the residents of the County of Summit, and for the further reason to immediately
48 provide for necessary architectural design work for the Project.
