A Resolution confirming the award by the Board of Control of a construction contract with Ohio Paving and Construction Co., Inc., for the Paving Improvement Project, for the parking lot at the Summit County Children Services Administration Building, located in the City of Akron, in Council District 4, in an amount not to exceed \$233,666.00, for the Executive's Department of Administrative Services—Physical Plants, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2022-294, which authorized the Executive to advertise for bids for the Paving Improvement Project, for the parking lot at the Summit County Children Services Administration Building (the "Project"), located in the City of Akron, in District 4, for a total not to exceed \$314,000.00; and

WHEREAS, after receiving five responses, the Executive selected Ohio Paving and Construction Co., Inc. was the lowest responsive and responsible bidder with a bid of \$233,666.00; and

WHEREAS, the Board of Control, at its meeting held on November 23, 2022, awarded the aforementioned construction contract with Ohio Paving and Construction Co., Inc., as the lowest responsive and responsible bidder, for the Project, in an amount not to exceed \$233,666.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information that the aforementioned construction contract with Ohio Paving and Construction Co., Inc. is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The award by the Board of Control of a construction contract with Ohio Paving and Construction Co., Inc., for the Paving Improvement Project, for the parking lot at the Summit County Children Services Administration Building (the "Project"), located in the City of Akron, in Council District 4, in an amount not to exceed \$233,666.00, is hereby confirmed, and the Executive is hereby authorized to execute said construction contract and any other necessary related documents.

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further reason to immediately provide for necessary architectural design work for the Project.
